About WEC

The Wisconsin Elections Commission (WEC) was established in 2016 by the Wisconsin Legislature to carry out a wide range of functions related to statewide elections administration.

The WEC serves as a resource for local clerks by providing them with education, training, and support materials. The agency also fulfills several statewide election responsibilities, such as helping ensure compliance with federal and state election laws, ensuring election accuracy, and maintaining the statewide voter registration database.

The WEC is governed by six Commissioners, with three Commissioners representing the Democratic Party and three representing the Republican Party. Two of the Democrats and two of the Republicans are selected by their respective Legislative leadership. One Democrat and one Republican must be former municipal or county clerks and are appointed by the governor and confirmed by the Senate.

Terms & Definitions

- **Absentee ballot** ballot not issued at a polling place on Election Day
- Canvass the process of verifying the totals from election day before certifying the results of an election
- **Elector** a US citizen who is at least 18 years of age, has resided at their voting address for at least 28 days, and is not disqualified from voting
- **Filing Officer** the person with who candidate paperwork, referendum, and other election-related materials are filed
- **Indefinitely confined** a voter who has difficulty getting to the polls due to illness, age, disability, or any other circumstance that would prevent inperson voting
- In-Person Absentee Voting (IPAV) A term for the period of time beginning 14 days before an election, when voters may vote absentee ballots at approved locations
- Military Voters absentee voters who are Members of a uniformed service or the U.S. Merchant Marine, Civilian employees of the United States and civilians officially attached to a uniformed service who are serving outside the United States, Peace Corps volunteers, spouses and dependents of those listed in the above categories residing with or accompanying them
- **Proof of Identification (POI)** a document proving a voter is who they say they are when requesting a ballot by absentee or in person
- Proof of Residence (POR) a document that establishes a registrant's connection to a particular location; proves the person lives where they say they do when getting registered
- Provider Usually a county that does WisVote entry for relier municipalities
- Relier Municipality that relies on a provider to do WisVote entry
- Special Voting Deputies (SVDs) individuals appointed by a municipal clerk or board of elections to conduct absentee voting at certain care facilities
- Witness a US citizen (unless voter is overseas) who is at least 18 years of age who witnesses you signing your absentee ballot

- Mar. 12- Online and By-Mail Registration ends for the Spring Election
- Mar. 28, 5pm Deadline to pre-register for the Spring Election


Absentee Voting Dates

- Jan. 27-Feb. 17 Primary SVD period
- Jan. 28 Deadline to begin mailing Primary ballots
- Feb. 4-18 Primary IPAV period
- Mar. 10-31 Spring SVD period
- Mar. 11 Deadline to begin mailing Spring Election ballots
- Mar. 18-30 Spring IPAV period

Note: <u>Most</u> absentee ballots must be requested by 5pm on Thur. Before the election.

Training Yourself & Your Poll Workers

- Municipal clerks must obtain six hours of training every two-year term from the WEC.
- Municipal clerks must take the MCT Core Curriculum Course to be considered certified to conduct elections.
- Election inspectors must attend training every two years and must have attended training within two years of the election in which they serve.
- Chief election inspectors must complete the Baseline Chief Inspector training and have at least six hours of training in total.
- Municipal clerks are in charge of ensuring election inspectors get trained.


Ways to Get Registered

- Online Up to 20 days before the election via MyVote only if you have a valid Wisconsin Driver's License or State ID card issued by the DMV.
- By mail Up to 20 days before the election. All registration forms should be mailed to the municipal clerk and include a copy of your POR.
 Residential leases cannot be accepted as POR by mail only.
- In the municipal clerk's office You may register in-person in your municipal clerk's office up until the Friday before the election at 5:00 p.m. or close of business, whichever is later.
- At the polls on Election Day You may register at the polls on Election Day.

Absentee

Absentee before IPAV begins:

- Clerks cannot accept absentee ballot requests in person before IPAV begins!
- State law requires a ballot be sent by mail to each voter with an active absentee request on file 47 days prior to the Presidential Preference Primary (overseas and military voters only), partisan primary, and general election and 21 days before all other elections
- Federal law requires a ballot be sent by mail to each military and overseas voter with an active absentee request on file 45 days prior to any elections with federal contests
- Municipal clerk must send absent elector a ballot within 1 business day of receiving the request

SVD Voting in Care Facilities:

- SVD voting must be conducted no earlier than the fourth Monday and no later than 5:00 p.m. on the Monday before the election
- Not less than five working days before the visit, the municipal clerk posts a notice of the absentee voting schedule at the facility

IPAV:

- IPAV may not begin any earlier than 14 days and must end Sunday before an election
- The 4th Tuesday before the election, the clerk must post the hours and location in which they are available in a Type E Notice

Deadlines for electors to make an absentee ballot request:

- Regular and overseas electors:
 - Online and by mail: Thursday before an election (single election) or Friday before an election (calendar-year)
 - In-person: the last day the clerk is offering IPAV.
- Military electors not away: Friday before the election.
- Hospitalized voters may request that a ballot be brought to them by an appointed agent any time in the 7 days preceding the election.
- Sequestered jurors and military away from home may request ballots on Election Day

Deadline to return or cure an absentee ballot:

8pm on Election Day

Absentee Process



Application Types


- Single election voters select the election they want a ballot
- Calendar Year voters choose to have all ballots in the year sent to them
- All future elections only indefinitely confined voters may request this and the application is deactivated when they request, or if they vote in person or don't return a ballot

Returned Absentee Ballots

Reviewing Certificates



WisVote Absentee Ballot Status Reasons

Active:

- returned
- not returned not properly returned
- returned to be rejected something is wrong with the certificate, the voter has been disqualified, the voter died before election day
- voter refused care facility voter declined to vote
- sent to voter for resolution certificate was insufficient and was mailed back to voter for correction

Deactivate:

- undeliverable ballot came back via post office because it couldn't be delivered
- voter spoiled voter decided not to vote the ballot and spoiled it
- admin action the clerk or staff did something wrong in issuing the ballot
- voter requested the voter decided not to vote absentee
- ballot not received the ballot never arrived with the voter
- returned after deadline -ballot gets to clerk after election day
